

ARTICLE VI POOLS, SPAS, SPORTS AND FITNESS FACILITIES

Section 6.01 Pools, Spas and Pool Areas

- A. Only SaddleBrooke Members/Owners, Associate Members, Qualified Renters or their Guests shall be allowed to use the pools, whirlpools and pool areas. They must have a valid HOA #2 ID card (Membership, Associate Membership, Renter, or Guest Card). (If a Guest is accompanied by a host with a valid HOA #2 ID card, a Guest Card is not required.) ***It is a violation to permit any others to use your key or code to enter the pool enclosures.***
- B. The pools, whirlpools and pool areas are open during posted hours which may vary seasonally. For the DesertView pool, the hours from 7:00 a.m. to 10:00 a.m. April 1 to October 31, and 7:00 a.m. to 11:00 am November 1 to March 31, are designated Lap Swimming only.
- C. Hours for people under the age of 18 are 11:00 a.m. to 1:00 p.m. at MountainView, 1:00p.m. to 3:00 p.m. at DesertView and 3:00 p.m. to 5:00 p.m. at the Preserve in the pool areas. Children who are not toilet trained are not allowed in the pools. During these hours, small toys are permitted provided they are not used in a disruptive or dangerous manner. The accompanying adult will be responsible for the proper use of these toys and all actions of their guests.
- D. At least one (1) designated adult must accompany any person under the age of eighteen(18). No person under the age of eighteen (18) is allowed in the whirlpools. No person under the age of eighteen (18) is allowed in the lap pool unless otherwise authorized by the Fitness Director or General Manager.
- E. To help keep the pools sanitary, all persons must shower prior to entering or re-entering the pools and/or whirlpools. Use of water-proof sunscreen is permitted.
- F. No smoking is permitted within the boundaries of all HOA #2 pool areas.
- G. No pets are permitted in any pool area at any time except for Service Animals.
- H. No toys (except those specified in Subsection C) or flotation devices are allowed except for one (1) single noodle, not exceeding six (6) feet in length, per person. Arm flotation bands or flotation vests for small children are allowed when accompanied by an adult in the pool.
- I. Proper swimming attire is required. Cutoffs, jeans or diapers are not allowed in the pools.
- J. No glass, food, or alcoholic beverages are permitted within the boundaries of HOA #2 pool areas, unless sponsored or approved by the Board or the General Manager. Nonalcoholic beverages in plastic or metal containers are permitted.
- K. A maximum of six (6) Guests for each SaddleBrooke Member/Owner Associate Member or Qualified Renter is allowed at any time unless otherwise authorized by the Fitness Director or General Manager.
- L. Running, diving, jumping into the pool, skateboarding, rollerblading or similar activities, and rowdiness are not allowed. For the DesertView pool, diving during lap pool hours is permitted.
- M. Classes have precedence over recreational swimming.

- N. Lap swimming is allowed in the MountainView lap pool and the designated lanes in the DesertView and Preserve pools. Lap swimmers must register and sign up for lanes. Lanes may be used for up to forty-five (45) minutes if other swimmers are waiting. Only lap swimming is permitted in these areas unless otherwise authorized.
- O. If a violation of this section is observed, notify Fitness Center personnel or the SaddleBrooke Patrol if Fitness Center personnel are not available.
